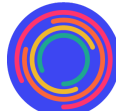


WHAT SETS TIGER 21 APART FROM OTHER PEER GROUPS?

Meeting Format	Monthly, full-day Meeting to address the opportunities and challenges that significant wealth creates	Monthly, half-day format in which Members share insights, experiences, and challenges	Monthly, full-day meeting to process issues with peers	Monthly, half-day peer-moderated meeting to confidentially discuss personal and professional challenges
Meeting Facilitation	 Led by a TIGER 21 Chair, a proven leader and professional facilitator who creates the space for Members to share collective intelligence	Facilitated by YPO members on a rotating basis	Led by a Vistage Chair , a highly-trained executive coach who mentors members to succeed at their highest level	Facilitated by trained peer moderators
